In 2025, we will continue to offer all these benefits and will focus on continuing to increase the value of HRA membership. Over the next year, HRA will make updates to and debut an updated website with improved navigation and additional self-serve features for members. We will work to transform more of our critical conversations and collaborations into concrete resources such as fact sheets and toolkits that will be housed in an improved resource library. We will conduct the first full Members' Survey since 2021 to solicit your feedback on current programs and ideas for the future. These are just some of the exciting initiatives to come in 2025!

I look forward to another outstanding year for HRA and encourage you all to become even more involved in our many programs, activities, and resources.

CONVENING CONVERSATIONS

In 2024, the Health Research Alliance convened more than 40 virtual conversations, bringing together 1500+ attendees to discuss a wide range of topics that are important to nonprofit funders. In addition to these virtual conversations, HRA hosted multiple opportunities for members to gather inperson.

CONVENING ON BULLYING AND HARASSMENT

The HRA Convening on Bullying and Harassment on February 26, 2024 brought together key stakeholders from nonprofit and federal funding organizations, academia, and the policy advisory sector to explore ways in which funders can prevent and address inappropriate behaviors (including bullying, harassment, and discrimination), both independently and in partnership with other sectors. This convening was generously hosted by the Doris Duke Foundation. The Misconduct & Ethics and Research Workforce & Early Career Development learning communities supported the planning of the convening.

NEW YORK REGIONAL MEETING

The New York Stem Cell Foundation
hosted a regional HRA meeting on
February 27, 2024, providing an
opportunity for more than 30 HRA
members to connect in-person. The event
included an exciting panel on "Accelerating
the Next Generation of Therapies"
featuring perspectives from the biotech,

venture capital, and academic sectors to explore where the gaps and bottlenecks are in accelerating therapeutics.

2024 MEMBERS MEETINGS

Following recommendations from the 2023 Members Meeting Task Force to leverage virtual meetings to increase meeting accessibility, HRA's <u>Spring 2024 Members Meeting</u> was entirely virtual! Our 15-person Program Committee organized an exciting meeting agenda and incorporated multiple methods by which virtual participants could engage with other attendees. Session topics included partnering with other funders, the impact of awardee career choice on funders' missions, measuring success, open science, and innovative methods for choosing among competing grant applications.

The Fall 2024 Members Meeting was hosted in-person in Alexandria, VA, and online via Zoom. The 21 Program Committee volunteers organized a thought-provoking agenda with topics including career advancement and partnering with other entities to achieve lofty goals, as well as the impact of anti-DEI legislation and artificial intelligence on nonprofit funders. Thank you to the member organizations who generously sponsored this meeting: Conquer Cancer, the ASCO Foundation, Foundation Fighting Blindness, Melanoma Research Alliance, and BrightFocus Foundation.

ENHANCING EFFECTIVENESS

HRA aims to enhance the effectiveness of our member organizations by providing resources, programming, and opportunities for community connection. We're proud to highlight three ways in which HRA delivered on this goal of enhancing effectiveness in 2024!

BIAS MITIGATION TRAINING RESOURCES

HRA has expanded the suite of Bias Mitigation in Peer Review Training resources to include trainings in multiple formats for varied audiences. In 2024, a Bias Mitigation Training for **Reviewers** was added to complement the existing training for **Program Staff**. This reviewer training is publicly available to maximize ease of access for scientific reviewers. In addition to the asynchronous eLearning versions of the trainings, both trainings are now available as downloadable facilitator toolkits. The toolkits include a slide deck containing visuals, case study videos, and a facilitator script; handouts; and a detailed facilitator guide with supplemental discussion activities. Members can use these materials as is or customize them to suit your needs!





PROFESSIONAL DEVELOPMENT PROGRAMMING

HRA facilitated multiple professional development events to enhance the professional skills and career advancement of individual HRA members. In 2024, HRA hosted three "Leading Up, Down, and Across" workshops facilitated by Molly Grisham, during which 100+ HRA members explored how to navigate influence across all levels of a team hierarchy. The Fall Members Meeting program included a session on "Career Advancement: Aligning Passion with Prosperity." during which speaker Shannon Bowen presented actionable strategies for career growth that integrate one's values and talents.

OPPORTUNITIES FOR CONNECTION

HRA organized several opportunities to connect with like-minded community members in 2024, both virtually and inperson. The Peer Circles program continued this year, with the third cohort kicking off in Fall 2024. The Peer Circles program introduces individuals with similar career roles from different HRA member organizations, who then meet monthly for the duration of the program to discuss shared interests, work challenges, and goals. HRA also organized opportunities for in-person connection, including two networking events associated with the Fall 2024 Members Meeting and regional meetings (New York in February, and an informal meetup in San Diego in April at AACR).

LOOKING FORWARD TO 2025

HRA will hold one virtual and one hybrid Members Meeting in 2025. The <u>Spring Members Meeting</u> will be all-virtual!
